ii)	Technician Apprentices (Mechanical - four posts) (Automobile - four posts)	a) A diploma in mechanical engineering/automobile engineering or technology granted by a State Council or Board of Technical Education established by a State Government. b) A diploma in engineering or technology granted by a University. c) A diploma in engineering or technology granted by an institute recognised by the State Government or Central Government as equivalent to (a) and (b) and (c) above. d) A sandwich course student who is undergoing training in order that he may hold a diploma mentioned in (a) ,(b) and (c) above.


And subject to conditions provided in the Apprentices Rules,1992 Section 3(2).

2. Standard of Physical fitness : As prescribed in the Apprentice Rules 1992 Section4(1) & (2).

3. Period of apprenticeship Training : One year
4. Payment of Stipend to : As per section 11 of The Apprentices Rules 1992. However, presently it is Rs. 16,000/- per month for Graduate Engineer, & Rs.14,000/- per month for Technician Apprentices/Diploma holders.
5. Selection will be based on **merit** in Degree /Diploma concerned.
