1) Introduction

The Central Institute of Road Transport (CIRT), Pune is a joint venture of the Ministry of Road Transport & Highways, Government of India and the Association of State Road Transport Undertakings (ASRTU). The Ministry of Science and Technology, Government of India also recognizes CIRT as a Scientific & Industrial Research Organisation (SIRO). It is one of the Premier Testing and Certification Agencies, authorized by the Ministry of Road Transport & Highways, Government of India under Central Motor Vehicle Rules – 1989 (CMVR) and Motor Vehicle Act 1988. It plays a pivotal role in formulating regulations for the Indian Automotive Industry.

CIRT is inviting proposals from an interested and experienced Consulting Agency/Firm with the main objective of qualifying and shortlisting consultant as potential candidate, willing and capable to provide consultancy services, for the preparation of a Detailed Project Report (DPR) for establishment of Advanced Automotive Testing and Development Centre (AATDC) at CIRT, Pune.

2) Background

The Central Institute of Road Transport, Pune under the Ministry of Road Transport and Highways has planned to empanel a capable and qualified consulting firm in the domain of Research, engineering and development of testing facilities for Automobiles.

The automotive manufacturers and auto-component manufacturers are facing challenges in terms of number of available vehicle and component testing options with respect to time, money and excellence in automotive testing and development. New and upcoming automotive regulations may lead to long service times for testing for the manufacturers and startups in this domain. As India aims to decarbonize the mobility and compete with global standards by making a paradigm shift from conventional automotive technologies to the sustainable technologies such as carbon neutral fuels, electric vehicles, Hydrogen Fuel cell technology, etc. and safety assist features like Advanced driver-assistance systems, etc. Also, development in areas like cyber security, where new regulations and standards will form a major part of vehicle testing.

3) Objective

The objective of this project is to empanel a consulting agency/firm which shall be responsible for the preparation of a Detailed Project Report (DPR) for establishment of Advanced Automotive Testing and Development Centre (AATDC) at CIRT, Pune with a futuristic vision of 15 years in areas of existing and developing technologies in automotive domain where future testing demand will exist. The test facilities shall be in-line with current and proposed AIS/GTRs. The DPR will detail the recommendations backed with research and data and would entail the requirements of the industry for the next 5 - 15 years.

In exceptional circumstances and at its discretion, Director, CIRT may extend the deadline for submission of proposals by issuing an amendment to be made available on the official website, in which case all rights and obligations of Director, CIRT and the participating agencies/firms previously subject to the original deadline will thereafter be subject to the deadline as extended.

a) EOI will be evaluated for short listing inter alia based on their past experience of handling similar type of projects, strength of their manpower, financial strength of firm and presentation/proposal to the selection committee whose decision will be final in freezing the scope of the RFP.

b) Short listed agencies are eligible to participate in the tender process of RFP for preparation of the DPR for AATDC at CIRT, Pune.

10) Response
