- F) Late / delayed and incomplete quotation will be rejected. CIRT shall not be responsible for any delays in transit or otherwise due to postal and/or any other reason.

- J) Delivery Server shall be supplied to CIRT within a period of 15-20 days from the date of acceptance of P. O. The server and its allied systems, sub- systems, computers, software's, other accessories as applicable shall be delivered to CIRT on DOOR DELIVERY basis at F.O.B. prices, without any additional cost to CIRT. All Incidental Charges shall be borne by successful supplier.
- K) The supplier shall provide suitable packing of the Server, as is required to prevent their damage without limitation, rough handling during transit. In case the consignment is received with damaged packaging, the CIRT, Pune would not accept the delivery. The Server shall be secured and protected from mechanical damage, moisture etc., suitable for both storage and transit according to the nature of the material and mode of transport.
